



## #PROJECT #GMP+2020

2017 marked the year that the GMP+ Feed Safety Assurance (FSA) scheme existed for 25 years. Our scheme has developed over time, to adapt to changes in the feed market and feed safety management. With this development, the certification scheme also became complex.

### General questions about #Project: GMP+2020

**1. Why are you changing the GMP+ Feed Certification FSA module?**

During the past 25 years, together with our partners, we also gained new insights in our scheme. It is now time to remove the complexity and apply the newly required insights via a systematic redesign of the GMP+ Feed Certification scheme. This will make the scheme more fitting in the current time and easier to work with for the GMP+ Community. It will also be clearer and more to the point.

**2. What exactly are you changing to the GMP+ FSA module?**

#ProjectGMP+2020 focusses initially on all standards of the current GMP+ FSA module. This means that mainly the entire structure and design of the scheme standards will change. It is important to know that the content of the standards will remain the same to assure a high level of feed safety.

**3. Will the GMP+ FRA module also be subject to any changes?**

Yes, the GMP+ FRA module will also undergo a renewal. The public consultation of this module is set to end on July 8th, 2020.

**4. What are the benefits for my organization due to the changes?**

- **A scheme which is more clear in requirements and structure.**  
The focus will be on feed safety with a clear and to the point set of requirements. The new structure will result in an harmonized set of requirements without duplications.
- **The requirements are more focused on the goal to achieve a high level of feed safety.**  
This approach allows you to determine how this high level is ensured. Goal requirements are set, but how to achieve compliance with these requirements is the responsibility of GMP+ certified companies. In some cases there will be requirements of a more detailed nature and may entail rules for achieving the Goal requirements. GMP+ International and its stakeholders are certain that these requirements are beneficial to feed safety and therefore your company.
- **Alignment with ISO 22000**  
ISO 22000 is a well-known and common used international standard. It is helpful to establish and operate a central control management system in which both the GMP+ standards and ISO 22000 are integrated and monitored. Therefor the ISO 22000 standard serves as a basis.

**5. When will the project finish and are the new scheme requirements applicable?**

**6. Will there be a transition period for the GMP+ Community?**

A transition period for implementation and certification will be applicable. This period will be 3 years, once publication starts on our website.

**7. What does the name #Project: GMP+ 2020 mean?**

We have decided to give this important project a special name. This will help to give recognizability to the project within the GMP+ Community. The name pretty much says it all but we use the hashtag symbol as a reference within our communication. The word “project” will indicate that this is important, something special which deserves attention, both from us as GMP+ International but also from our GMP+ Community. The “GMP+2020” description refers to the GMP+ Feed Certification scheme and the year 2020 will indicate the timing of the project. Not only when this project will be finished but it also means that we are preparing for the future.

**8. Where can I find more information regarding the project?**

**9. As of when can I view the GMP+ FC scheme “2020”?**

In July 2020, the temporary, final draft version will be shared with the GMP+ Community via our website. Once the board of accreditation has approved the draft, we will publish the final, new documents.

**10. When can I expect updates regarding the project?**
